CHAUHAN

- 1. I HAVE NOT WANTED TO JUMP TO HASTY CONCLUSIONS IN THIS DIFFICULT AND TANGLED STORY. BUT IN THE LIGHT OF EVENTS SO FAR, AND OF THE NEW EVIDENCE SUMMARISED IN MY 2ND 1.F.T., MY CURRENT ASSESSMENT IS AS FOLLOWS:-
 - (A) RAJIN GANDHH'S ENTOURAGE ARE EXTREMELY ANGRY WITH US.
 - (B) IN THIS THEY ARE PARTLY REFLECTING THE INCOMPREHENSION AND ANGER WITHIN INDIA, TO WHICH THEY ARE PARTICULARLY SENSITIVE AT ELECTION TIME.
 - OUR INACTION, HAVING ALREADY BEEN IN THEIR BELIEF, SUB-STANTIATED OR NOT, A CONTRIBUTIRY FACTOR TO THE MURDER OF MRS GANDHI, IS CONTINUING TO CONTRIBUTE MATERIALLY TO THE DANGER OF RAJIV BEING SIMILARLY KILLED.
 - (D) THEY BELIEVE HIS EARLY DEATH WOULD ENDANGER INDIA'S NATIONAL SURVIVAL.
 - (E) THEY ARE CONVINCED WE COULD FIND SOME WAY OF ACTING AGAINST CHAUHAN IF WE REALLY WANTED TO.
 - (F) THEY HAVE ORDERED THE MEA TO APPLY POLITICAL AND ECONOMIC PRESSURES TO BRING US TO THAT PATCH.
 - (G) IN PURSULAT OF THIS THE MEA HAVE ORDERED ALL GOVERNMENT
 DEPARTMENTS TO CONSULT THEM BEFORE UNDERTAKING ANY IMPORTANT
 CONTRACTS WITH US.
- 2. WHATEVER WE SAY, WE SHALL NOT ALTER THIS STAGE OF AFFAIRS UNLESS AND UNTIL WE DO TAKE WHAT IS ACCEPTED AS EFFECTIVE ACTION.

 MY THIRD IFT CONTAINS SOME IDEAS FOR MY FURTHER DIALOGUE WITH RASZOTRA. BUT THEY WILL NOT AFFECT THE BASIC ATTITUDES DESCRIBED ABOVE.
- ATTEMPT BEING MADE ON RAJIN'S LIFE IN THE NEXT FEW MONTHS, PROBABLY BY SIKHS, AND THAT, IF THIS HAPPENS WHILE WE ARE STILL TOLERATING CHAUHAN, THE EFFECT ON ALL OUR INTERESTS HERE COULD BE CATASTROPHIC. LIVES AND PROPERTY COULD BE LOST AS WELL AS CONTRACTS AND INFLUENCE.

4. WE THEREFORE NEED TO ASK OURSELVES WHETHER, IN THE ABSENCE OF NEW EVIDENCE AGAINST CHAUHAN, THERE ARE ANY CIRCUMSTANCES IN WHICH WE WOULD FEEL OBLIGED TO DO SOMETHING ABOUT HIM: AND IF SO, WHAT WE WOULD DO AND WHETHER WE MIGHT NOT BE WISER TO DO IT NOW.

5. I DO NOT UNDERESTIMATE THE DIFFICULTY OF TAKING ACTION. NOR CAN I FROM HERE DO MUCH MORE TO SUGGEST WAYS AND MEANS. BUT I MUST LEAVE YOU IN NO DOUBT OF THE DANGEROUS AND DAMAGING CONSEQUENCES OF DOING NOTHING.

MY TWO I-PT'S: CHAUHAN

- 1. IT IS NOW CLEAR, AS REPORTED IN MY TEL NO 969, THAT GOVERNMENT DEPARTMENTS HERE HAVE BEEN WARNED OFF CONCLUDING MAJOR CONTRACTS WITH BRITAIN IN PRESENT CIRCUMSTANCES.
- 2. IN HAVE LITTLE DOUBT FROM THE TONE OF MY TALK WITH THE MEA ON THE SUBJECT (MY TEL NO OTTER 372) THAT THE 'POSTPONEMENT' OF THE MAJOR SBAC EXHIBITION AND SEMINAR IN FEBRUARY IS A RESULT OF THIS NEW DRILL. THE MEA OFFICIAL CONCERNED TOOK LITTLE TROUBLE TO CONCEAL HIS HOSTILITY. OUR CONTACTS IN THE OTHER GOVERNMENT DEPARTMENTS CONCERNED ARE EMBARRASSED BUT HELPLESS.
- FOR DEFENCE'S VISIT IN FEBRUARY NOW ALSO BEGINS TO LOOK LIKE PART OF THE SAME PATTERN, ALTHOUGH MY FIRST THOUGHT WAS THAT IT MIGHT BE GENUINELY ELECTION—RELATED. II AM PRETTY SURE THAT THEY WILL ALSO VETO MR LAMONT'S VISIT. IT WAS ENCOURAGING THAT WHEN I SAW HIM ON 7 DECEMBER THE CHIEF OF PROTOCOL THOUGHT THERE WOULD BE NO DIFFICULTY ABOUT REINSTATING PRINCESS ANNE'S VISIT (INFEBRUARY)

BUT HE ASKED FOR TIME O CONSULT HIGHER AUTHORITY AND COULD YET BE TOLD TO CHANGE HIS TUNE.

- 4. WE ARE GETTING MONSSAND MORE REPOTTS THAT THE DISSATISFACTION OVER CHAUHAN IS SOURING THE ATMOSPHERE FOR OUR BUSINESS PROSPECTS:

 AND THAT IT CENTRES IN RAJIN GANGHI'S POLITICAL ENTOURAGE AND MORE GENERALLY IN THE HIGHER REACHES OF THE CONGRESS (ID) PARTY.

 THE LATEST AND CLEAREST COMES FROM A WELL-PLACED AND WELL-DISPOSED BUSINESS CONTACT, WHO ASKED TO SEE ME ON 7 DECEMBER. HE IS A MODEST MAN, NOT GIVEN TO THE INDIAN PRACTICE OF EXAGGERATING HIS INTIMACY WITH THE GREAT. HE HAD BEEN TALKING TO A MEMBER OF RAJIN'S POLITICAL HOUSEHOLD AND HAD FOUND THEM IN AN UGLY MOOD. THEY WERE SURE THAT IF WE CHOSE WE COULD FIND SOME WAY OF PREVENTING A MAN LIKE CHAUHAN DOING SO MUCH DAMAGE TO INDIA. OUR ATTITUDE MUST THEREFORE REB MSENT CULPABLE NEGLIGENCE IF NOT DELIBERATE MALICE.
- WENT ON TO SAY THAT AS A RESULT OF OUR CONSIDERABLE RECENT EFFORTS OUR CHANCES OF SECURING THE HUGE CONTRACT FOR 155MM FIELD HOWITZER HAD BEEN BEGINNING TO BRIGHTEN. BUT THE INDIAN MINISTRY OF DEFENCE WERE NOW CLEAR THAT ADVICE TO BUY BRITISH WOULD BE UNWELCOME AT THE POLITICAL LEVEL, AND SPECIFICALLY TO THE PRIME MINISTER'S ENTOURAGE. THE INDIAN SYSTEM BEING WHAT IT WAS, THEY WOULD THERFORE NOT RECOMMEND OUR GUN UNLESS THINGS HAD CHANGED BY THE TIME THE DECISION CAME TO BE TAKEN AFTER THE ELECTIONS.

6. AS THINGS STAND WE HAVE NO SPECIFIC EVIDENCE OF DANGER TO OTHER PENDING CONTRACTS SUCH AS THE WE 30 HELICOPTER DEAL, BUT WE CANNOT RULE THIS OUT.

MIPT: CHAUHAN

- 1. FAILING OR PENDING ACTION AGAINST CHAUHAN I CAN THINK OF ONLY ONE TYPE OF PALLIATIVE LIKELY TO GAIN US AT LEAST A RESPITE. THIS WOULD BE TO SEND TO DELHI A VERY HIGH-LEVEL PERSONAL EMISSARY FROM THE PRIME MINISTER. HE WOULD NEED TO BE A POLITICIAN OR EXPOLITICIAN AND PREFERABLY ALSO A LAWYER, WHO COULD TALK WITH FULL POLITICAL AND LEGAL AUTHORITY TO RAJIV GANDHI AND OTHERS HERE ABOUT EXACTLY WHAT WE CAN AND CANNOT DO AND WHY.
- 2. UNLESS OF COURSE WU WERE WILLING TO UNDERTAKE SUCH A MISSION YOURSELF, THE ATTORNEY GENERAL WOULD BE THE SORT OF EMISSARY IN HAVE IN MIND. A FORMER LAW OFFICER COULDHBE ANOTHER POSSIBILITY. WHILE HT MIGHT BE POSSIBLE TO KEEP SUCH A VISIT SECRET, THERE WOULD PROBABLY BE REAL ADVANTAGE IN GIVING HT FULL PUBLICITY, AS AN EARNEST OF THE SORT OF TOP-LEVEL CONCERN WHICH THE INDHANS BELIEVE WE DO NOT FEEL AT PRESENT. HT MIGHT THEREFORE BE USEFUL TO ARRANGE A BACKGROUND SESSION BETWEEN THE EMISSARY AND SOME LEADING INDIAN EDITORS AND COMMENTATORS, WHO AS YOU WILL KNOW ARE A HIGH-POWERED AND INFLUENTIAL GROUP HERE.
- 3. AS TO TIMING, IN SHOULD NEED OF COURSE TO PREPARE THE GROUND WITH RAJIN GANDHI'S OFFICE AND THE MEA: AND ACCOUNT WOULD HAVE TO BE TAKEN OF THE ELECTION CAMPAIGN. BUT OTHERWISE THE SOONER THE BETTER.
