
As discussed on the telephone, please find enclosed a selection of our OZONE friendly Asda Brand body sprays deodorants and hair sprays.

Dear Mr. Morris,

Further to our telephone conversation, I am pleased to forward the Tesco Cares information as discussed.

On Ozone specific issues, we have completely replaced the CFC solvents in our entire range of aerosol products and of course all new products will be 'ozone friendly'. The plastic foam packaging, previously formed using CFC gas is now blown with pentane, and fibre board has replaced plastic in some egg packaging.

All new stores (24 due in 1989/90) are fitted with refrigeration plants which use R22 solvent. Whilst this is still a CFC type it is considerably less damaging than the CFC 11 and CFC 12 type solvents. Longer term we anticipate the successful development of the 134a type solvents.

The wider issues of environmental care are addressed in our booklet, which we have distributed free to our customers in every one of our 380 stores since we launched our campaign in January.

I hope you will find the information interesting and useful. If there is anything else I can add, please do not hesitate to contact me.
